

## Terms and Conditions for “Purchase RWC 2011 ticket(s) to matches at Wellington Regional Stadium and be in to win RWC 2011 Final tickets” Promotion – August 6 to August 20 2011

1. Entry is only open to New Zealand residents aged 18 years and over with a ticket delivery address in a Wellington postcode. For the purposes of this Promotion, “Wellington” includes ticket delivery addresses with a Wellington Region Postcode (Includes Porirua, Lower Hutt and Upper Hutt). Employees (and their immediate families) of Rugby World Cup Limited (RWCL), the International Rugby Board, Rugby New Zealand 2011 Limited (RNZ 2011) and any of their respective agencies are ineligible for the Prize Draw.
2. Promotion commences at 9.00am on Saturday August 6 2011 (NZST) and closes at 5.00pm on Saturday August 20 2011 (NZST) (“Promotion Period”). The Promotion consists of one Prize Draw. The prize is two Category C tickets to the RWC 2011 Final at Eden Park, Auckland, on October 23, 2011 valued at approximately NZD\$1,500.
3. One entry into the Prize Draw will be automatically awarded to eligible entrants upon the completion of a qualifying purchase during the Promotion Period. A qualifying purchase is any purchase transaction via [www.rugbyworldcup.com/tickets](http://www.rugbyworldcup.com/tickets) or a RWC 2011 Official Ticket Outlet during the Promotion Period that includes ticket(s) to any Rugby World Cup 2011 (RWC 2011) match scheduled to be played at Wellington Regional Stadium, Wellington. One entry will be awarded per qualifying purchase transaction by an eligible entrant. RNZ 2011 takes no responsibility for lost, stolen, misdirected or incomplete entries.
4. The prize winner will be drawn at random from all valid entries received during the Promotion Period. The draw will take place at the offices of RNZ 2011’s Ticketing Agent at 11am Monday August 22 2011. The first entry drawn that meets the eligibility criteria will win the prize.
5. The prize winner will be notified within 5 days of the Prize Draw taking place using the contact details provided at the time of the qualifying purchase. If an ineligible entry is drawn or the winner is unable to be contacted within 10 days of the prize draw, the winner will be deemed to have forfeited their prize and a re-draw will take place. In the event of dispute of identity of the drawn winner, the winner will be the RWC 2011 Tickets Account holder under which the qualifying purchase was made. RNZ 2011’s decision on entries and the winner is final and no correspondence will be entered into.
6. All Rugby World Cup 2011 tickets are issued subject to the RWC 2011 Ticket General Terms and Conditions (Ticket Conditions) which apply to the possession and use of Tickets. Tickets are non-transferable except as set out in the Ticket Conditions. Tickets cannot be used for commercial or promotional purposes or resold for more than their original sale price.
